Chairman Jansen called the Public Hearing to order at 7:30PM

PUBLIC HEARING -- Re: Horvath Communications/Verizon Cellular Tower

Richard and Marcia Ray (7406 Lake Road) expressed their concern that there has been an issue regarding "brown outs" in their power due to activity at Mayer Bros. and that flickering now happens more frequently. They shared their concern that a heavier draw on the the power grid from the impending cellular tower could make things worse. They said that National Grid installed a reader on the meter at Mayer Bros., and expressed that equipment could be added to mitigate the problem, but it is costly.

R. Hanson stated that the tower is a normal 220 and pulls less electricity than a house does. He was unsure if the brown outs could affect the efficiency of the cellular tower and that he would share this information with Horvath.

M. Ray asked when the project would start? R. Hansen said that it would not begin until the end of this year, or even January or February of 2021. The project still needs Tribal Approval, which has been slowed because of the pandemic.

Concern was expressed by J. Hotaling regarding the tower's possible disturbance to nesting eagles.

A written statement was distributed by J. Hoffman reviewing the design package for the tower which approves the absence of guy wires and lights on the tower. He urged that current and future towers follow the same guidelines.
