

DOG LICENSES: We are receiving numerous complaints about dogs not being under the control of the owner. After investigating, we find that these dogs are not licensed. New York State law requires dogs age 4 months or older to be licensed. You may bring your up to date rabies information to the Town Clerk's Office to purchase the license. License fees are \$6.00 for spayed and neutered dogs and \$16.00 for all unspayed and unneutered dogs. If a dog license is not paid within 60 days of the date of renewal, there will be a \$10.00 late fee added to the license fee. Town Law requires dogs be under the control of the owner at all times. Unfortunately this is not always the case. Please help us keep a safe environment and license your dog (s).



PASSPORTS: Our office is a processing agent for passports and passport photos. If you are anticipating traveling out of the country, please contact my office for information on what is required. You may also access our website for information.

<u>ON-LINE PAYMENTS:</u> In order to better serve you, I am currently working with a company to make utility bills and taxes available for payment on line. Watch our website for further information. I hope to have this service available by early January.

HISTORIAN'S CORNER

Mary B (Seeley) Lapage passed away on October 29, 2011. Born on October 24, 1910, she was the fourth child of Glen and Cora Seeley. It is believed that she was the last child to be born in the 30 Mile Point Lighthouse. Her father was the lighthouse keeper from 1903-1945.

At an interview with Lorraine Wayner in 1995, Mary remembered how difficult it was for her parents to get the kids to school. There was a dirt road leading to the lighthouse and there were no snow plows at that time so her father had to shovel a lot of snow. She said they borrowed a horse and cutter many times to make the trip to the country school that her brothers and sister attended. Mary didn't attend the country school because by the time she was ready for school, the 1911 building of Barker Central School was completed and they attended school there.

Mary recalled that when they had company, she would always take her friends to the top landing of the lighthouse so they could see the countryside and the lake. Mary's parents liked animals and at times had quite a variety. She remembers they had a pet monkey and one day her mother hung out the laundry and hitched the monkey by the back door near the clothes line. She went inside to continue her household chores and when she came back out to get the clothes, the monkey had apparently gotten cold and pulled the clothes down and was wrapped up in them to get warm.

NEWS FROM THE HIGHWAY DEPT. Kenneth J Bigelow, Superintendent of Highways 795-3866

Just a few friendly reminders from the Highway Dept: leaving snow on the highway is prohibited by Section 1219 of the Vehicle and Traffic Law and Section 214 of Highway Law of the State of New York.

Parking on any Town Road is prohibited in accordance with provisions of the Town of Somerset code 191-15 as specified in Schedule XI (191-33) 2:00 a.m. to 6:00 a.m. From November 1 to April 1.

The bridge project on Lower Lake Road between Quaker and Johnson Creek roads is finally completed. The IPP (Initial Project Proposal) was submitted to the NYSDOT on 5/9/2008 and the new bridge opened to traffic on 10/31/2011. Thirty nine months of design and finding our way through governmental red tape and approximately 3 1/2 months for construction. Thanks goes to Wendel Duscherer Engineers and CATCO Construction for a job well done. The old twin pipes were installed in 1955 and served the Town well.

I am confident that the new structure will also.

I would like to thank everyone for your patience and cooperation during this year filled with bridge construction and town highway resurfacing projects. Multiple jobs have been completed including several Niagara County bridge deck repairs.

Water/Sewer Department News

A few reminders from the Water/Sewer Department:

DOUBLE CHECK BACKFLOW PREVENTION DEVICES are required on all new construction and when there is a CHANGE of property owner. Final readings for property sold will include inspection for the double check valve.

For your safety and that of your neighbors, please keep the **fire hydrant** by your house clear of trees, shrubs and snow. This is crucial in case of a fire and for the maintenance of the hydrant. New York State law requires a minimum of 3 feet of clearance.

To minimize the possibility of sewer problems, snow and debris should be kept clear of your **sewer vent pipe.** Also, care should be taken not to damage your vent pipe during snow removal. Please contact us if your vent pipe has been damaged.

If anyone comes to your door saying he is from this department and needs access to your house regarding your water or sewer, he will be driving a marked Town of Somerset truck and will have **Town employee identification**. If this is not the case, do not let them in and call this Department immediately at 795-9919.



<u>Is Your House Number</u> <u>Visible from the Road?</u>

some of our residences have reflective markings on their house or close to it, however, we find that the house numbers on at least 1/2 of our residences are non-existent or not visible from the road. What will the Emergency Responders do if you have an emergency at your home? Precious seconds and minutes will be wasted trying to locate you. **PLEASE** consider purchasing a reflective sign from our Junior Firemen. Order forms are available at the Town Hall. Councilman's Corner

The 2012 Budget:

Greetings to the residents and businesses of Somerset.

A recently published article in a local newspaper has raised some questions regarding the Town's 2012 budget. Accordingly, I thought it would be informational to provide a brief outline of the budget process and list just a few highlights.

The process begins with the Supervisor gathering information from the Department Heads. They provide estimates of the revenue and expenditures that can be expected from their departments during the upcoming year. External service providers also provide information relative to their areas of expertise. Examples of these service providers are: The Barker Volunteer Fire Department, The Village of Barker - for local Police Services and the current legal and engineering firms. After this information is gathered, the Supervisor takes into account all of the other sources of revenue, such as sales tax and all of the other expected expenditures. He prepares his Proposed Budget and presents it to the Town Board. The Town Board reviews the proposed budget line by line during publically announced work sessions. The Department Heads and external service providers are invited to this session as well. Upon completion of their review and after incorporating whatever changes were agreed upon, the Board schedules a Public Hearing for the residents and taxpayers to provide their input. After the Public Hearing, the Board inserts any changes that may have resulted from their input and adopts the Final Budget for the upcoming calendar year. There are statutory deadlines in place to make sure that this process moves along at an efficient, but not hurried pace.

Some highlights of the 2012 Budget include:

Despite what was reported in the local newspaper, Town taxes will not go up.

The 2012 budget is \$495,387 less than the 2011 budget.

A specific line item has been added that designates funds for economic development.

Modest pay raises of 2% were given to all full time employees and part time appointed officials.

The Supervisor and Councilpersons will not be receiving any increase in salary or benefits.

The adopted 2012 budget for the Town is \$3,538,249



NEWS FROM THE FIRE DEPARTMENT

This is the time of year that we use our alternative heating devices, wood stoves and fireplaces. I would like to remind those of you who use fireplaces and woodstoves, to have your chimneys cleaned and inspected yearly BEFORE using your stove. A chimney fire happens quickly and without warning. They can burn inside your walls for hours without detection. They're especially dangerous when no one's home. By the time the fire's discovered, it's usually too late to save the home.

Another cause of many house fires is the use of power strips. The problem is that people use these devices with appliances that require too much electricity causing the power strips to overload. Regardless of internal circuit breakers, these devices still fail. If you're going to use them, DO NOT plug in any more appliances than the strip can handle. Be sure that the power strip has a UL label and has been tested. The \$1.99 power strips at discount stores ARE NOT SAFE. Many of these strips do not have the safety features that are required by the Underwriters Laboratories.

As always, the members of the Barker Fire Dept are here to assist our residents in the practice of fire prevention. If you need us to help you establish a fire escape plan or any other fire prevention matter, do not hesitate to call me at 471-6080 at anytime. I, or one of our firefighters, will be happy to come to your home and assist you.
