Upon learning of a discrepancy between the bid and State pricing, Supervisor Engert investigated and found the discrepancy arose from the two entities using a different cycle. Drum Oil bases their pricing on the daily rate while the State maintains a weekly rate, both based on the Journal of Commerce. Discussion ensued regarding fuel delivery and monitoring the price variances each year.

**WHEREAS**, General Municipal Law Section 103(16) permits any board of a political subdivision to "piggyback" off another political subdivision for purchases of goods and equipment if such contract was let to the lowest responsible bidder; and

**WHEREAS**, the County of Onondaga, by bid reference number 7974, put out for sealed bids the furnishing of Ford 550 XL Reg Cab 4 x 4 with options and body and associated options and said bid allowed all municipal entities authorized under the General Municipal Laws of the State of New York to purchase goods under this Bid Contract; and

**WHEREAS**, Van Bortel Ford of East Rochester, NY was the awarded this bid Contract by the County of Onondaga; and

**WHEREAS**, the Town of Somerset finds it is in the best interest of the Town to "piggyback" off of the County of Onondaga Bid No. 7974 as permitted by General Municipal Law Section 103(16); now therefore be it

RESOLVED, that the Town of Somerset Highway Superintendent is hereby authorized to purchase a 2015 550 XL Reg Cab 4 x 4 with 9 foot steel cross-member and Super Duty Hitch Wing System from Van Bortel Ford of East Rochester, NY as allowed for under the awarded County of Onondaga Bid No. 7974 at a cost not to exceed \$91,813.24 and said expenditure shall be taken from the 2015 budget.

# POLICE EQUIPMENT

# LAKESHORE ACCESSORY BUILDING REGULATION

Attorney Norris provided the board with an overview of the meetings held by the Planning Board. He stated that it was discussed thoroughly by the members from June through October 2014. If a resident lives on the north side of the road and owns property on the south side of the same road, the resident can build a structure on the south side following certain regulations. The vote by the Planning Board was split 3-2. Attorney Norris will find out if this will also have to go the County Planning Board.

Councilwoman Jansen introduced the Local. Then, on the motion of Councilwoman Jansen, seconded by Councilman Alt, the following resolution was

Resolved a Public Hearing will be held on March 11, 2015 at 6:30PM to hear and consider the following amendment:

Repeal §205-34 (B) in its entirety and replace with:

B. Before there can be any accessory building or accessory use in a Residential Lake Shore District (RLS), there must first be a principal use or principal dwelling on the lot, except as provided in §205-35 (B).

Repeal §205-34 (C) (1) in its entirety and replace with:

All accessory buildings shall be set back a minimum of 100 feet from the road right of way.

Add §205-35 (B)

B. An accessory structure on a vacant parcel on the south side of a road if the property owner who owns such parcel also owns a parcel on the north side of the same road and directly on the lake shore with a principal structure located on it. The Planning Board shall take into consideration and review the structure's overall appearance and proposed location, including but not limited to: architectural styles, design materials, and colors; the surrounding area including the impact of lake views and other buildings located in area; and the overall aesthetic enhancement of the Town and the Lake Shore District. Any approval of the Special Use Permit by the Planning Board may be conditioned upon its review of the foregoing considerations.
