### RESOLUTION 111-2016

## **CONSTABLE CHIEF**

Supervisor Engert stated that he has many duties in his role of Supervisor including taking on the responsibility of Police Chief when the department was established. He listed his responsibilities and stated that he has relied on Deputy Supervisor Wayner a lot more than in the past. He said with all that is in front of the Town Board, he needs to prioritize his time and feels that it is in the best interest of the Town to appoint a Chief for oversight of the department. He recommends John Yotter, our most senior officer, who is a decorated retired Detective, and received the distinction of Officer of the Year from Governor Cuomo. Supervisor Engert arrived at a suggested salary by averaging the annual salaries of our Code Enforcement Officer, Dog Control Officer and Senior Citizen Director.

Councilman Wayner said this is a great application of resources and thanked Supervisor Engert for his efforts with the police force.

<u>Jim Hoffman</u> invited the Board to a viewing of a film called Big Wind, a Canadian documentary being presented by SOS.

<u>Wally Coates</u> spoke as President of the Barker Fire Department. He told about a distress call they answered recently that was far from the road. Miguel (one of our officers) was called in and he offered to block the road. The Fire Department declined his offer, but Miguel stayed on the scene. Wally is glad that he stayed because a woman ran the blockade and bumped a couple of firemen. She was belligerent and was determined to

keep driving through the scene. Miguel reached in and grabbed her keys to keep her from continuing. Wally thanked the police department and said that Miguel behaved in the utmost manner.

Supervisor Engert stated that the level of activity since 2012 when he started preparing detailed reports is shocking.

<u>Cathi Orr</u> thanked Highway Superintendent for installing a sign by their driveway. Discussion ensued regarding the procedure of the Highway Department to obtain signs.

Marcia Ray feels our liberties and freedoms are being threatened by taking away our local voice. She stated that Article X is unfair, and the sacrifices are unreasonable and unaffordable. She said it is a burden to our small town and wants them to look for a better location.

<u>Taylor Quarles</u> provided an update. He stated that the stipulations process is continuing. He has heard there is confusion regarding the process and said that he is willing to have conversations about it. They are updating the FAQ sheet on their website and would like input if anyone thinks of something they would like to see as part of it. They continue to have office hours 4 days/week but that may get interrupted now and then due to events.

Bev Herriven referred to a comment that was made a couple of months ago that this was a done deal and APEX had everything under control. She thinks APEX was dishonest by telling residents if they don't sign their neighbors down the road will sign.
