BUDGET SUMMARY

Supervisor Engert provided the following:

- In 2008 PILOT revenue was \$1.3 million; in 2018 the revenue is \$139,000 which is a reduction of 89%.
- The board has strategically lowered the rate; invested in making the "West parcel" shovel-ready; negotiated cost-sharing; and consolidated departments. There are no more areas to cut without cutting services.
- In 2008 the A Fund had reserves equal to 150% above what was in the budget line. The board used reserves each year to offset the taxes and keep the rate low to create a climate to be favorable to new businesses and homeowners. Now the plant has decided to invest in a solar facility on the west parcel so the board has to reevaluate its strategy. The reserve is \$500,000, of which the proposed budget will use half and have a tax rate of \$1.68/1,000 which is a 58% increase over the 2012 rate. In comparison to other towns that have a village, our rate is still low. Hartland has a rate of \$2.48, Royalton is above \$3.50 and Wilson is over \$3.00. The comparison is against towns with villages because these towns cannot use sales tax to offset the A fund. The other towns can use it and some of them do not have a Town tax.

- While this is a large increase, the taxpayers have benefited from a very reduced tax rate for the past 5 years.
- Various things come into play: the wind developer has impacted the costs of the town and we are in negotiations for the next PILOT.

The Supervisor talked about the future of the plant being unknown because Gov. Cuomo has stated that coal plants have to repower to natural gas or retire by 12/31/2020. Supervisor Engert reached out to Senator Ortt regarding a mitigation fund that will help offset some of the lost revenue when the plant closes. He asked the Senator to advocate to change the rule so the funds can start flowing into the town and school district. Senator Ortt will hold a senate hearing at some point in 2018 to raise awareness of the impact of the plant on the grid and the economy.

Councilwoman Jansen advised that the board has looked at other options such as shutting down the town hall a couple days per week or doing alternative staffing. She was not interested in pursuing any of that and thinks this budget is the best we could hope for at this point.

Councilman Dewart stated that the department heads have worked hard the past few years to cut costs. Supervisor Engert agreed and said they have been exceptional to work with and have done their best to look for different ways to implement things and he appreciates it.

Supervisor Engert said the tax cap came into place so other alternatives were limited without overriding the cap which would cost the residents the rebate. He said we will continue to fight to not further erode our tax base allowing an industrial wind project to completely transform the town.
