Supervisor Engert called the meeting to order at 6:30PM with the Pledge to the Flag and a prayer for guidance.

# **PROCLAMATION FOR BCS Winter Sports Champions**

Supervisor Engert read a proclamation honoring the Barker Varsity Swimming team and the coaches on a winning 2013-2014 season. At the Niagara Orleans League meet, the girls posted 13 Personal Best Times, and the boys earned 10 Personal Best Times. The boy's team was honored with the Niagara Orleans League Sportsmanship Award. He also recognized Tim Flint, John Stansbury, Casey Webb and Collin Webb for claiming the 200 Free Relay league championship honors, and the Section VI Class C school championship.

A second proclamation was read by Supervisor Engert honoring the Barker Varsity Wrestling team. He recognized Brent Bachman for winning first place at the Niagara Orleans League All League championship in his weight division.

Supervisor Engert then read a third proclamation honoring the Barker Varsity Boys' Basketball team. They finished with a record of 18 wins and 0 losses, making this the only perfect season in Barker Boys' Basketball history and giving them the Niagara Orleans League Championship for the first time in 35 years. Jake Haight finished his high school career as the all-time leading scorer in school history with 1,338 points. He led the league in scoring and steals, and was 2<sup>nd</sup> in rebounds. Jake was named to the 4<sup>th</sup> Team All WNY honors, All BCANY Section VI Small Schools and 1<sup>st</sup> Team All-League for Niagara Orleans League. Mitchell Luckman led the entire Section VI in assists, and the Niagara Orleans League in free throw percentages and was 4<sup>th</sup> in Niagara Orleans League scoring. He was selected to the 1<sup>st</sup> Team Niagara Orleans All-League. Bryce Moeller led the league and Section VI in blocked shots, and was named to the 2<sup>nd</sup> Team Niagara Orleans All-League. Christopher Sweeney finished 2<sup>nd</sup> in 3 point scoring for the Niagara Orleans League, and was selected to the 2<sup>nd</sup> Team
