Clerk Connolly stated a monthly communication was received from Time Warner regarding channel lineup.

SUPPORT OF SECOND AMENDMENT

Clerk Connolly stated a resolution was received from the Town of Clarence opposing the NYS SAFE Act. Clerk Connolly stated the resolution adopted by the Town Board at the March meeting was sent to the officials with no communications being received to date.

VETERANS OUTREACH PROGRAM

Clerk Connolly announced that the Town of Somerset is working with the Niagara County Clerk for a veterans outreach program that will enable veterans the ability to go to their town hall to have a private meeting with someone from the Veterans Agency. She stated that all Town Halls are participating and the date for Somerset is August 13, 2013.

RESOLUTION 53-2013

CEMETERY REGULATIONS - Proposed Local Law #3

Superintendent Denny stated the regulations have been updated with the committee. He said they reviewed other town's regulations and updated what would be best for Somerset.

Councilman Wayner said there has not been an adjustment for pricing since 1996 and the majority of the costs are labor.

Supervisor Engert stated that he would like to see that there is an addition for holiday/weekend burials in extenuating circumstances.

On the introduction of Councilman Alt, seconded by Councilman Jansen, the following resolution was

Resolved a proposed local law to repeal and replace Chapter 82, "Cemeteries" is introduced with a public hearing to be held on May 14, 2013 at 7:00 p.m.

LWRP (Local Waterfront Revitalization Program) UPDATE

Supervisor Engert stated a grant application was submitted to update the LWRP but the town was not awarded the grant during that cycle. He said there are two areas that require updating and he had a conference call with the Engineers and the Department of State (DOS) to discuss the options. He said they suggested that we reapply and suggested a memorandum be submitted to point out the clarifications that need to be made regarding the maps and the sewer service area.

Engineer Roeseler stated DOS agrees with the interpretation of the document and that a memorandum be sent to obtain a legal opinion. He stated there is a difference between the sewer district and a sewer service area of which we currently have. He stated any new project would need adequate infrastructure to service their needs and a septic could still meet the needs of the project.

Supervisor Engert stated they intend to reapply for the grant when the funding opens up and will send a memorandum.

SHOVEL READY SITE UPDATE

Supervisor Engert stated the funding source for the shovel ready site has not come to fruition but the Town is moving forward in a proactive position with development and marketing of the site. He said the Engineer is working on another avenue for funding. He stated the marketing brochure has been finalized and is being distributed by the Niagara County Economic Council throughout Southern Ontario and Northeastern states.

ASSESSOR

Supervisor Engert stated Dominic Penale will be leaving at the end of April but will represent the Town at Grievance Day in May. He stated Anthony Dispenza has been moving forward and has some great ideas for educating the public via the website. He also suggested sketching software be purchased to save time when drawing diagrams on the property record cards which are currently done manually.

RESOLUTION 54-2013

SOLAR ENERGY SYSTEMS ASSIGNMENT

Supervisor Engert stated the Planning Board has been discussing regulating solar energy systems. He said he met with Chairman Hotaling regarding this issue and suggested the Planning Board be assigned this.

PRIVILEGE OF THE FLOOR

He said the town is not currently issuing building permits for those installations and feels that a permit should be issued as it is a structure. He said the Planning Board has been looking at several ordinances and the Board is drafting one. He said that Chairman Hotaling and he attended a meeting at the Fire Hall regarding the safety and structural analysis of the structures.
