TOWN OF HARTLAND BICENTENNIAL CELEBRATION

Clerk Connolly read a letter from the Town of Hartland requesting the Town participate in the celebration on July 28th, 2012.

LAKE ONTARIO WATER LEVEL REGULATION PLANS

Clerk Connolly read a communication that was sent by Supervisor Engert requesting the International Joint Commission delay any public meetings on any proposal to modify Lake Ontario water level regulation plans until such time that the majority of affected parties will be able to attend.

Supervisor Engert stated the hearing has been postponed for March and Senator George Maziarz will be facilitating a meeting at the Town Hall on February 16th with Supervisors from Niagara and Orleans Counties along affected areas of Lake Ontario.

BARKER CHEMICAL REMEDIATION

Supervisor Engert announced that a \$25,000 grant has been received from National Grid to fund a Phase II Environmental Site Assessment Review of the 10-acre parcel. He said the property has been off the tax rolls for years and would like to be able to market the property once it has been declared clear of contamination. He said if contamination is found, this study will put the property in a more favorable light for additional grant funding.
