ATTORNEY REPORT

Attorney Jones reported the following:

- 1. There has been a RGGI Lawsuit (Regional Greenhouse Gas Initiative) filed challenging the State's entry and participation in the program as the mandate was not approved by the State Legislature. He stated that he has sent a letter to the lead Attorney in New York City stating the Town supports the lawsuit and would participate. He said he has tried to contact him and will continue to do so. Mr. Morgan stated the lawsuit claims the mandate is an unconstitutional tax passed onto the consumer, among other items.
- 2. He met with Assessor Glidden and the Niagara County Real Property Tax Office regarding the procedures that are followed regarding the transfer of property at the Lighthouse Christian Camp on Form RP 5217, explaining his investigation. He said he has determined that the Assessor's office can accept the RP517 for the conveyance of the lease. He stated the agreement that was executed in February 2011 between the Town and the Lighthouse Christian Camp is acceptable. He stated that he does not know if the Town can charge a recording fee for the filing of the forms as the recording fee goes to the county and state. He said he does not recommend charging a fee.
- Stated that he had forwarded memorandums to the Board regarding prohibiting the use of compression release engine brakes (Jake Brakes), code enforcement and smoking in parks.
 - a. Discussion ensued regarding the safety of Jake brakes versus the noise.

SMOKING IN TOWN PARK

Councilman Engert stated that he had met with Councilman Jansen and Superintendent Denny regarding the request for the Town to ban smoking in the town park. He stated that the Somerset Youth Baseball Organization (SYBO) has been contacted regarding the matter and said the matter will be taken care of internally with SYBO. He said that no ordinance is recommended.

Superintendent Denny stated there could be some signs put on the back stops that would be just a message and he will look into it.

ASSESSOR'S QUARTERLY REPORT RECEIVED AND FILED.

COMMUNICATIONS:

Clerk Connolly said a resolution has been received from the Town of Newfane supporting the RGGI resolution.

Clerk Connolly stated notification has been received from Time Warner increasing the rate of HBO.

Clerk Connolly stated that a communication has been received from NYSDEC regarding wastewater treatment plant operator certification and that DEC is transferring the administration of the program to NY Water Environment Association (NYWEA) and that a fee will be charged for certifications of the operator license.

Clerk Connolly stated that she met with Joe Hickman from Modern Disposal regarding the expansion of their recycling program and stated that the information will be placed in the newsletter.

Code Enforcement Officer Hildebrant reported the site has been reviewed and he will be meeting with Ed McDonald from Mercy Flight to make sure their needs are met when they stake the site out.
