RESOLUTION 139-2011

LOWER LAKE ROAD BRIDGE

Randy Roeseler stated there are four items that need to be addressed:

- 1. Final payment for the construction contractor.
- 2. Need to reallocate the engineering portion of the project costs. He said the costs have not changed.
- 3. Line item adjustment to pay the payment request upon contractor closeouts.
- 4. Final local share of the cost of the bridge.

He said the bridge is done and 90% has been paid for by grant monies. He went over the entire costs in detail and said there is a net change to the contract of \$33,354.33 based on adjusted quantities found out in the field, including rock excavation that had to go down further down than originally anticipated and the bridge being 3 $\frac{1}{2}$ feet wider than what was originally planned. He said that increased the cost by approximately \$15,000. Mr. Roeseler explained the fabrication of the box culvert and that a wrong

dimension was used. He said the plans were reviewed at all three engineering levels with no one picking up the mistake.

Attorney Jones asked if there was an advantage to having a wider bridge.

Michael Leydecker said there is more cover over the water line and there are some benefits on the road.

Discussion ensued regarding what would have happened if they were stopped at the time it was discovered and who is responsible to pay for the \$15,700 increase.

Mr. Roeseler stated there needs to be reallocation of the under runs of the time and expense items to the inspections. He said they do not anticipate using all of that but there has been overruns on the inspection side.

Mr. Roeseler said there needs to be a line item adjustment so a budget amendment needs to be made. Superintendent Bigelow stated that there was not enough money budgeted for the bridge so there has to be an amendment.

Mr. Roeseler stated that a letter to the state has been crafted for Superintendent Bigelow to send requesting additional funds to cover the increased construction costs. He said the State has not said no, but they will look at the request.

Extensive discussion ensued regarding paying for something that is not the fault of the Town; engineering responsibility; the Town's recourse if the bill is not paid; the cost of litigation; the cost to the Town if the State does not comes through with funds; withholding payment for further discussion with contractor; and making partial payment of the bill.

On a motion of Councilman Engert, seconded by Councilman Alt, the following resolution was

Resolved the net change request of \$17,654.33 be made for a total amount of \$152,212.58 being authorized for payment to CATCO reserving payment of the \$15,700.00 in dispute.

POLICE CONTRACT

Councilman Engert said the Board received a proposed contract from the Village of Barker and stated there were concerns about the amount (\$50,000.00) requested by the Village. He stated that there has been no agreement reached on the issues.

Councilman Alt stated that he would like to see the Town Board have a say in the hours and coverage.

Councilman Wayner stated he thought there was significant progress made after Councilman Engert and Chief Annable met, however is disappointed that it has gone nowhere. He stated the costs of police coverage since he became a Councilman has substantially increased and does not feel confident that a contract for police services can be signed at this time.

Supervisor Meyers said it may be best to try to extend the contract to the year end of the Village budget to buy time to work out an agreement.

Extensive discussion ensued regarding moving forward; advantage of extending the contract for a few months; other options for police coverage; possibility of a public hearing to get the input from the public; the cost of the service; lack of response from the Sheriff's Dept. and Troopers; specifics in the contract; discrepancy of dollar amounts that have been used for discussion; the need for the Boards to sit down together to work out an agreement; the dollars requested from the Village being based on the mileage in the town versus the village and fines that the town receives from the use of the police department; Town adjudicating Village cases and Town expenses associated with that; the need for an official response to the \$50,000 contract the Village has proposed; and the expiration of the contract on December 31, 2011.

Supervisor Meyers said if need be the Board will hold a special meeting to resolve the matter.
