RESOLUTION 57-2020

UPFIT OF POLICE CAR

On a motion of Councilwoman Jansen, seconded by Councilman Leuer, the following resolution was

WHEREAS, the Town purchased a 2014 Dodge Charger for use as a police vehicle in the Town of Somerset Police Department; and

WHEREAS, the vehicle requires retrofitting to be utilized as a fully functional and effective police vehicle; and

WHEREAS, the estimated cost to retrofit the vehicle is between \$3,000 and \$10,000; and

WHEREAS, the Police Chief solicited verbal quotes for the retrofitting work to the police vehicle and received one response from Empire Emergency in the amount of \$5,992.76.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Somerset hereby authorizes the Police Chief to contract with Empire Emergency to retrofit the 2014 Dodge Charger for use as a police vehicle in an amount not to exceed \$5,992.76; and be it further

RESOLVED, that the Supervisor and Police Chief are authorized to execute any and all documents in such form as is satisfactory to the Town Supervisor and the Town Attorney, and take whatever other actions may be necessary to give effect to this resolution.

Attorney Haylett stated that some work that was quoted is not needed so Chief Miller expects the cost to be lower.

This item was budgeted for \$50,000 but the project is expected to cost \$30,000 or less.

Councilman Leuer asked about the status of the other stations and Supervisor Dewart told him he believes they will be part of Phase 4, but he will double check with Superintendent Dewart.
