WHEREAS, the lowest responsible proposal was received by Munibilling, with offices at 3300 Battleground Ave., Greenboro, NC 27410 in the amount of \$11,500.00 for training and conversion and \$6,341.40 for the annual subscription;

NOW, THEREFORE, BE IT RESOLVED, that the Town of Somerset hereby authorizes the Town Supervisor to contract with Munibilling, 3300 Battleground Ave., Greenboro, NC 27410 to upgrade the water/sewer billing system at an amount not to exceed \$11,500.00 for training and conversion and \$6,341.40 for the annual subscription fee for 2021.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Somerset hereby retains Sheridan Benefits LLC with offices at 7 Limestone Drive, Williamsville, NY 14221 to act as Agent/Broker of record for the Town's health insurance coverage; and be it further

RESOLVED, that the alternative plan's benefit structure and provider network shall be substantially equivalent to the current plan.
