**WHEREAS,** Apex Clean Energy began the siting process for a 201 MW wind energy project titled the Lighthouse Wind farm in 2014; and

**WHEREAS**, as a result of the proposed project, many town residents have attended monthly board meetings and public information sessions and contacted Town Board members by various means of communication to express concerns, opinions and frustrations about the potential Industrial Wind Project within our community; and

**WHEREAS**, public input at numerous Town Board meetings over the last five years has indicated that residents are opposed the siting of massive industrial projects such as Lighthouse Wind in areas where there is little public support and a clear mismatch between the development goals of the town and profit motives of the wind energy companies; and

WHEREAS, the Town Board enacted numerous amendments to the Town of Somerset Zoning ordinance designed to better protect the health, safety and welfare of the citizens of the Town of Somerset and also to ensure that local land use laws will more faithfully uphold the development goals and objectives set forth in the Town of Somerset Comprehensive Plan; and

**WHEREAS**, previous Town of Somerset Town Board's have expressed their opposition to the proposed Lighthouse Wind project; and

**WHEREAS**, this Town Board desires to express its continued opposition to the proposed project.

**NOW THEREFORE BE IT RESOLVED,** that the Town Board of the Town of Somerset hereby opposes the application of Lighthouse Wind LLC for a Certificate of Environmental Compatibility and Public Need Pursuant to Article 10 to Construct a 201 MW Wind Energy Facility; and be it further

**RESOLVED,** that the Town Board of the Town of Somerset calls upon Apex Clean Energy to withdraw its application with the New York State Board on Electric General Siting and the Environment to site industrial wind turbines in the Town of Somerset
