WHEREAS, General Municipal Law Section 103(16) permits any board of a political subdivision to "piggyback" off another political subdivision for purchases of goods and equipment if such contract was let to the lowest responsible bidder; and

WHEREAS, Delaware Chenango Madison Otsego BOCES, by bid reference number 2019-150, put out for sealed bids the furnishing of Vehicles and Trucks and said bid allowed all municipal entities authorized under the General Municipal Laws of the State of New York to purchase goods under this Bid Contract; and

WHEREAS, Van Bortel Ford was the awarded this bid Contract by the DCMO BOCES; and

WHEREAS, the Town of Somerset finds it is in the best interest of the Town to "piggyback" off of the DCMO BOCES Bid No. 2019-150 as permitted by General Municipal Law Section 103(16);

NOW THEREFORE BE IT RESOLVED, that the Town of Somerset Highway Superintendent is hereby authorized to purchase a 2020 Ford F-250 XL SuperCab 4x4, as provided for under the DCMO BOCES Bid No. 2019-150, Lot 13A from Van Bortel Ford at a cost not to exceed \$54,206.80 and said expenditure shall be taken from the 2020 budget.

INFLUENT PUMP STATION REPAIR

Attorney Haylett advised that there were 4 proposals received by the Town. Pipe Eye is the lowest at \$19,660.00. United Survey came in second lowest at \$31,250.00. Arold Construction came in at \$35,000.00 and Kandey Company came in at \$60,135.00. He said because the lowest bid was so much lower than the highest bid that he checked with Wendel. They have worked with Pipe Eye in the past and Wendel is confident they can handle it.

Superintendent Dewart said the inside of the concrete tank at the station on Quaker Road by the plant is being lined.
