WHEREAS, the Somerset Operating Company, LLC (Somerset), a 675 MW coal-fired generating plant in Barker, NY, has proposed to retire the plant ahead of the Governor's 2020 "no coal" deadline and repurpose the facility as a 500 MW data center using renewable energy; and

WHEREAS, the plan to repurpose the 1800-acre Somerset plant is a component of the "Empire State Data Hub", a \$650 million capital investment plan which seeks to close the last two operating coal plants in New York State (the other being the 309MW Cayuga coal plant in Tompkins County) by taking advantage of a skilled local work force and valuable on-site attributes that include existing electric infrastructure, expansive land, and a moderate climate critical to largescale data centers; and

WHEREAS, the Empire State Data Hub would represent a significant economic boon for the Upstate economy, creating 600 Union construction jobs and 200 full time jobs in aggregate, with average salaries in the \$40,000 to \$60,000 range, while also creating a stable, increasing revenue model for local governments; and

WHEREAS, Empire State Data Hub would invest \$550 million into the Somerset campus making it the largest capital investment in Niagara County history, and would create 500 Union construction jobs, and 160 full-time employees; and

WHEREAS, the Somerset Operating Company, LLC currently employs approximately sixty (60) employees in the Town of Somerset that are facing imminent risk of losing their job due to the projected plant closure in 2020; and

WHEREAS, the Empire State Data Hub proposal in the Town of Somerset provides an ideal opportunity to transition the current Somerset Operating Company, LLC employees to well-paying jobs as opposed to the unemployment line; and

WHEREAS, the Somerset campus of the Empire State Data Hub would focus on the growing demand for the computational power necessary in the burgeoning businesses of artificial intelligence, machine learning and high-performance computing; also proposes a separate plan to construct a solar facility as part of the site's future expansion and

WHEREAS, the Town of Somerset has taken a strong and unanimous position in support of this redevelopment plan, which is fully in line with the goals of the Town's Comprehensive Plan and LWRP; and

WHEREAS, the Data Hub proposal is enthusiastically supported by a broad and unified coalition of key stakeholders including environmentalists, labor unions, local elected officials, business leaders, and local school district officials; and

WHEREAS, an application seeking 125 MWs of renewable energy is currently being considered by the New York State Power Authority, as well as an application seeking

economic assistance from Empire State Development Corporation to transition the Somerset site; and

WHEREAS a strong position by the Town of Somerset in support of the Empire State Data Hub proposal is critical to its success.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Somerset determines the Somerset Operating Company's proposal to deactivate the coal plant and convert the site into a large-scale data center powered by renewable energy from nearby Niagara Falls and solar energy will greatly benefit the economy and the environment of this region; and be it further

RESOLVED, that the Empire State Data Hub plan also recognizes the economic opportunity inherent in this energy transition by seeking to shift from the old economy of coal to the new economy of high technology while utilizing renewable energy to power economic growth; and be it further

RESOLVED, that the Town of Somerset urges the New York State Power Authority to approve the Empire State Data Hub application seeking a 125 MW allocation of fair and reasonably priced renewable energy – representing an almost 10 to 1 MW shift from fossil fuels to green energy; and be it further

RESOLVED, that the Town of Somerset urges Empire State Development Corporation to approve the Empire State Data Hub's application for \$65 million in economic assistance as part of the overall \$650 million capital investment to transition the Somerset site from an aging coal plant to a modern, large-scale Data Hub; and be it further

RESOLVED, that a copy of this resolution be sent to Governor Andrew Cuomo, NYPA President Gil Quiniones, NYPA Board of Trustees Chair John Koelmel, ESD Executive Director Howard Zemsky, State Senator Panel Helming, State Senator Robert Ortt, Assemblywoman Barbara Lifton, Lansing Town Supervisor Ed LaVigne, Deputy Secretary for Energy and Environment Dale Bryk, Director of Policy John Maggiore
