TOWN BOARD SPECIAL MEETING March 24, 2021

A Special Meeting of the Town Board of the Town of Somerset, County of Niagara and the State of New York was held at the Town Hall, 8700 Haight Road, Barker, New York on the 24th day of March 2021.

Supervisor Dewart called the meeting to order at 4:00PM with the Pledge to the Flag.

Clerk Carmer stated for the record that we received two complaints regarding the time of this meeting.

PUBLIC HEARING - POLICE REFORM

Clerk Carmer read the notice of public hearing. Notice of said hearing was sent to the Lockport Union-Sun & Journal on March 15, 2021 with same notice being posted on March 19, 2021 at the Town Hall and on the website.

Chief Miller distributed a monthly police activity report for all to review, and provided a background on the collaboration issued by the Governor in June 2020. He advised that he posted a survey on our website and formed a review committee that consists of himself, Councilman Hotaling, Burton Munn, Father Joseph, and Meg Denny. The survey resulted in 39 responses: 16 favorable, 16 informative, and 7 undecided. He stated that transparency is one area they focused on. The police activity report is prepared monthly and shall be placed on the website. However, it was brought to our attention that over the past year the reports have not been posted on the website. He stated that they have prepared daily patrol logs since their inception in 2012 and they are a matter of public record. This collaborative has resulted in a standardized civilian complaint procedure: if a complaint is regarding the inappropriate handling of an incident, then a call should be made to Chief Miller. If the complaint is a serious allegation, the complainant shall come in person and file

a formal complaint with the Police Chief or the Town Supervisor. He stated that an area with a lot of response on the survey is the police budget. He advised that the budget is passed by the Town Board and is also a matter of public record. Chief Miller said that he has to balance the needs of the community and his officers are part-time and abide by civil service rules. All of the officers have body cameras and the film is required to be kept on file for 6 months unless it is a criminal matter then it has to be kept longer. Chief Miller discussed the increased training that his officers are undertaking. He plans to start submitting articles for the Town newsletter and they now have an email address somersetnewyork@gmail.com. Regarding public trust he reiterated that they have body cameras, their reports are open, and they have a ride-along policy where any member of the public is welcome to ride along with an officer to see what they do. He discussed complaints of Somerset cars being seen in Newfane or elsewhere and had advised that we follow a "closest car" policy for officer safety and will respond to calls outside of Somerset if we are the closest car.

Krista Atwater said that she would like to see more patrols during the day on weekends. She lives near Black Bird Cidery and there is increased bad behavior related to traffic between the hours of 9-5.

Chief Miller also discussed what they do for the elderly. Besides doing house checks they will be attending the Barker Seniors meetings.

Norm Jansen thanked Chief Miller for performing a welfare check on a friend of his. Had it not been for that check, he believes his friend would not be with us today.

Patty Ray discussed the theft that occurred at her property in October. She said that Niagara County sent the Somerset police and the Somerset police told her to get more surveillance cameras even though they had all of the necessary details. The Village of Barker police contacted her for assistance the next morning. She stated that the situation of Barker vs Somerset made her feel mildly uncomfortable. She said that the Town of Somerset Police could do more community outreach to lessen residents' fear of the police.

Ricky Ray said that the Village police helping them was a situation where the police went where needed. He'd like to see the Town contract with the Village like we used to and have the Village cover some shifts.

Patty Ray said that the quality of service is as important as the quantity.

Ricky Ray asked why the report that was distributed was from December and not current?

Chief Miller answered that it just happened to be the report that he grabbed.

Agnes LaPorte stated that she had a favorable experience with the police when her mailbox was destroyed. Within a few days the person was located.

Krista Atwater complimented the police department and said that she has been here for 35 years and has always had positive results with the department. She said that they are trustworthy people and also complimented the Town Board for their quick responses. She feels that this is all overkill by New York State.
